This Rental/Lease Agreement ("Agreement") is entered into between **SH OH Truck Repair, LLC** ("Lessor") and the above-named Lessee for the rental of a parking space at the Lessor's facility. By signing this Agreement, the Lessee agrees to the following terms and conditions:

### TERMS AND CONDITIONS

**1. RENT** \_\_\_\_\_ (initial)  
Lessee agrees to pay a monthly rent of \$189.00 for the Large Spot parking space (For vehicles 40ft and above). Rent is due on the 1st day of each month. A late fee of \$25.00 will be assessed for any payment received after the 5th of the month. All payments shall be made via the method designated by the Lessor.

**2. TERM** \_\_\_\_\_ (initial)  
This Agreement is for a month-to-month rental period. The rental period begins on the date of space assignment and continues until terminated by either party with a minimum of thirty (30) days written notice.

**3. SECURITY DEPOSIT**

\_\_\_\_\_ (initial)

A security deposit equal to one (1) month's rent may be required at the Lessor's discretion. The deposit will be held by the Lessor and returned within thirty (30) days of termination, less any amounts owed for damages, unpaid rent, or other charges.

**4. USE OF PREMISES**

\_\_\_\_\_ (initial)

The parking space shall be used exclusively for the storage of the Lessee's designated commercial vehicle(s). No hazardous materials, flammable substances, or illegal goods shall be stored on the premises. No vehicle repairs, maintenance work, or modifications shall be performed on the premises without prior written consent from the Lessor.

**5. INSURANCE**

\_\_\_\_\_ (initial)

Lessee shall maintain valid commercial vehicle insurance covering all vehicles parked at the facility at all times during the term of this Agreement. Proof of insurance must be provided upon request. SH OH Truck Repair, LLC is not responsible for any damage, theft, or loss to the parked vehicle(s) or their contents.

**6. LIABILITY / INDEMNIFICATION**

\_\_\_\_\_ (initial)

Lessee agrees to indemnify and hold SH OH Truck Repair, LLC, its officers, employees, and agents harmless from any and all claims, damages, losses, costs, or injuries arising from the Lessee's use of the parking facility. Lessee parks at their own risk. The Lessor assumes no liability for damage caused by weather, natural disasters, acts of God, vandalism, or third-party actions.

**7. ACCESS & SECURITY**

\_\_\_\_\_ (initial)

Lessee will be provided with a gate access code for 24/7 entry to the facility. This access code is personal and confidential and shall not be shared with any unauthorized individuals. SH OH Truck Repair, LLC reserves the right to change access codes at any time with reasonable notice. Unauthorized sharing of access codes may result in immediate termination of this Agreement.

**8. CONDITION OF SPACE**

\_\_\_\_\_ (initial)

Lessee shall keep the assigned parking space and surrounding area clean, free from debris, and in good condition. Any damage to the facility, pavement, fencing, gates, or other property caused by the Lessee or the Lessee's vehicle shall be repaired at the Lessee's sole expense.

**9. ABANDONMENT**

\_\_\_\_\_ (initial)

Any vehicle left on the premises for more than thirty (30) days after the termination of this Agreement or after thirty (30) consecutive days of non-payment shall be considered abandoned. The Lessor may have the vehicle towed and stored at the Lessee's sole expense. The Lessor shall not be liable for any damage or loss to an abandoned vehicle.

**10. SUBLETTING**

\_\_\_\_\_ (initial)

Lessee shall not sublet, assign, or transfer their parking space to any third party without the prior written consent of the Lessor. Any unauthorized subletting shall constitute a material breach of this Agreement.

**11. DEFAULT**

\_\_\_\_\_ (initial)

If the Lessee fails to comply with any term or condition of this Agreement, the Lessor may provide ten (10) days written notice of default. If the default is not cured within the notice period, the Lessor may terminate this Agreement and require immediate removal of the vehicle from the premises.

**12. TERMINATION**

\_\_\_\_\_ (initial)

Either party may terminate this Agreement with a minimum of thirty (30) days written notice. Upon termination, the Lessee must remove the vehicle and all belongings from the assigned space by the last day of the notice period. Vehicles remaining after the notice period may be towed at the Lessee's expense.

**13. GOVERNING LAW**

\_\_\_\_\_ (initial)

This Agreement shall be governed by and construed in accordance with the laws of the State of Ohio. Any disputes arising from this Agreement shall be resolved in the courts of Medina County, Ohio.

**14. ENTIRE AGREEMENT**

\_\_\_\_\_ (initial)

This Agreement constitutes the entire agreement between the parties and supersedes all prior negotiations, representations, or agreements relating to the subject matter hereof. Any modifications to this Agreement must be made in writing and signed by both parties.
